

## **Terms of Reference**

#### General

The Nanopreterm is a Special Interest Group of the British Association for Perinatal Medicine.

## **Background and rationale**

There has been increasing interest internationally in the management of babies born 22-23+6 weeks gestation. Recently published <u>research in BMJ medicine</u> showed a three-fold increase in the number of babies provided survival focused care and admitted to neonatal units in England and Wales following a change in the 2019 BAPM extreme preterm framework. Similar to most other countries, survival remains poor, with only 20% survival of babies provided survival focused care, and 30% survival of those admitted to neonatal units. A higher proportion of babies with unfavourable characteristics (born earlier in the first half of the week, no antenatal steroids, <500g) were provided survival focused care following changes to the framework. These findings suggest that a more universal rather than risk-stratified or selective approach, as recommended by the BAPM framework, is being followed.

The paucity of research in this new population of babies makes this a very evidence-poor area of neonatal care. There is a need to bring together neonatal professionals to share experiences and drive research that will contribute to advancing knowledge and improving outcomes. As the numbers in each unit and network are small, coming together regularly to learn together means learning can be disseminated more rapidly, which will improve the knowledge of neonatal professionals across the country.

### Vision

Nanopreterm's vision is to build a multi-professional community focused on delivering optimal care and improving outcomes for the smallest and most immature babies. This will be achieved by sharing experiences and learning through national and international discussion forums, collaborative audits, quality improvement and research projects, identifying research priorities, and developing frameworks with principles of best practice as the evidence evolves.

### **Group Membership**

Nano-preterm SIG members are professionals caring for extremely preterm born babies. This may include doctors, nurses, advanced nurse practitioners, allied Healthcare Professionals (including dietitians, psychologists, pharmacists, physiotherapist, developmental therapists), midwifery, obstetrics, former patients and families, as well as charities and other relevant organisations. Healthcare professionals must be BAPM members.

#### Responsibilities

- 1. To build a collaborative community of multi-professionals that meet regularly to discuss experiences and share learning, with an aim to improve the care and outcomes of the smallest and most preterm babies.
- 2. To identify areas of uncertainty and challenges which will inform quality improvement initiatives and research recommendations.

- 3. To support, facilitate and participate in regional, national and international research that will inform improvements in care and outcomes for the most preterm babies.
- 4. To organise and support educational and networking events that focus on the care of the smallest and most preterm babies.
- 5. To develop practical resources that will support neonatal teams to deliver consensus best practice care for babies born at 22 weeks. This may include a consensus framework of principles of best practice.

### Formation and structure

The Nano-preterm SIG Executive Committee (EC) will consist of representatives from across the country in a range of professional roles including allied health professionals, nurses and doctors. Applications to join the SIG EC will be advertised to BAPM members and other professional organisations where applicable. The EC officer appointments (chair, meeting secretary, research and education leads) will be made by membership vote. Subsequent appointments will be made by existing committee members. Applications will be anonymised before review. All Nanopreterm SIG and EC members need to be members of the BAPM.

Committee members are elected for a term of three years, and they can also be re-elected for a second term. The following positions with associated responsibilities will be advertised with open application from BAPM members.

**Chair** - Suggests and follows through actions from meetings and workstreams if appropriate. Chairs the Committee meetings, ensures responsibilities are on track, and liaises with individual members, BAPM and other relevant organisations. Acts as spokesperson for the SIG.

**Meeting Secretary** – maintains list of Executive committee members, sets up online meetings, circulates notes after meetings and maintains an action log.

**Research lead** – to take responsibility for development and maintenance of the research work plan for the group. This may include getting consensus on research recommendations and signposting the latest research to group members.

**Education lead** – to take responsibility for development and maintenance of the education work plan for the group.

QI Lead - to take responsibility for development and maintenance of the QI work plan for the group.
