The Lost Mothers Project report launch

The Lost Mothers Project is a collaboration between Dr Laura Abbott at the University of Hertfordshire, Birth Companions, and an advisory team of women with personal experience of pregnancy, motherhood and separation from a baby while in prison. This groundbreaking project brings vital focus to the needs and experiences

of women who are separated from their infants due to imprisonment. It also considers the experiences of the health and social care professionals and prison officers who play a central role in delivering care and in shaping the outcomes for these women and their babies.

Last week, the Lost Mothers Project final report and policy spotlight paper were launched at an impressive event at the British Library. At the event, Clean Break staged a performance of their powerful play based on the research, *Scenes from Lost Mothers*, and members of the Lost Mothers research team, Birth Companions and Clean Break also took part in a moving Q&A session.

New perinatal support service in HMP Eastwood Park

Last month, we launched our new perinatal support service in Eastwood Park prison, where our coordinator will be working alongside specialist volunteers and trained peer supporters to deliver a programme of wellbeing activities, weekly groups, and one-to-one support for pregnant women and mothers who are separated from babies in the community.

Despite changes to prison policy in recent years, navigating pregnancy and early motherhood within the harsh prison environment remains one of the most challenging experiences imaginable. We are so pleased to be able to offer our specialist support to more women through this new service, and to harness the power of lived experience and peer support to make our work there as impactful as possible.

The Izzy Project

Our Hackney-based support service for women at risk of or experiencing separation from their babies shortly after birth, the Izzy Project, was featured this week in a blog from the Agenda Alliance.

In the blog post, our Izzy Project Coordinator Helen and LET member Brooklynn discuss the service and its co-design process, and reflect on why support services like this are so vital for women facing separation from their babies.

1001 Days in the CJS campaign



Birth Companions recently launched our latest campaign, calling for an ambitious new approach to pregnancy, birth and early motherhood across the whole criminal justice system.

Evidence shows that what happens in the first 1001 days from conception to a child's second birthday lays the foundations for their long-term physical and mental health and wellbeing. Yet the criminal justice system – policing, courts, prison and probation – is ill-equipped to deal with this critical period in the lives of mothers and their babies. This is creating huge risks to women, and the life chances of their children.

That's why we're calling for a radically different approach to the 1001 days across the criminal justice system, through significant changes to policy and practice. The work of the Women's Justice Board, the Partnership Delivery Group, and the Independent Review of Sentencing present real opportunities for change. We have to seize them. We invite you, our partners and supporters, to join us in making the 1001 days a priority across the whole criminal justice system.
