J-P MacNamara is a criminal defence lawyer. He qualified as a solicitor in 2011 and worked for a number of years for a top 100 London-based law firm before being promoted to partner in 2016. He subsequently worked for GT Stewart Solicitors as a Higher Court Advocate. He has appeared in the Crown Court for a range of criminal offences including serious violence, firearms and kidnap cases.

He has appeared as Junior Counsel in a number of murder cases and has appeared as Leading Junior in a conspiracy linked to a murder trial. In 2020 he cross-qualified as a barrister and holds a door tenancy at 33 Bedford Row. J-P is also a full-time staff member at the City Law School, City St Georges, University of London where J-P is a Senior Lecturer and also serves as Associate Dean: Enterprise, Engagement and Employability. J-P was shortlisted in the 2015 and 2016 Law Society Excellence Awards in the category of "Solicitor Advocate of the Year" and won "Lawyer of the Year" with the Surrey Law Society in 2019.
