

# **GERMAN NTD YOUTH AMBASSADOR PROGRAM**

In October, the first German "Neglected Tropical Diseases" (NTDs) Youth Ambassador program" has started as a joint initiative of the working group for NTDs (AG NTD) within the "young DTG" (German Society for Tropical Medicine, Travel Medicine and Global Health e.V.) and the German Network Against NTDs (DNTDs).

NTDs affect over a billion people worldwide, especially children and the youth. Thus, the WHO NTD Road Map 2021-2030 highlighted importance the engagement for NTDs.

The program aims at engaging students and young professionals early in the field of NTDs and thus including more young voices in advocacy, policy and awareness raising for this group of diseases.

Leonie Maier, a medical student from Leipzig university, is Germany's first NTD Youth Ambassador. In the following, Leonie will introduce herself and her motivation to take part in the program.

My name is Leonie Maier, I live and study in Leipzig, and since October 2025, I am a Youth Ambassador for Neglected Tropical Diseases (NTDs). The program combines many topics that have accompanied and moved me in recent years: global health, international cooperation, medical expertise, and the question of how to make healthcare more equitable.

NTDs affect more than 1.7 billion people worldwide - especially children and young people and are emblematic of global inequalities and structural disadvantage. Yet in our crisisridden times, NTDs and the fate of those who suffer from them often remain invisible. It is precisely this invisibility that makes them so political. Reminding us that health is not a neutral space, it challenges us to think about power relations, responsibility, and prioritization in the global health discourse.

I am motivated by the conviction that young people can and should play an important role in this process. As an NTD Youth Ambassador, I want to help raise awareness and visibility of NTDs in Germany and build bridges between medicine, society, and politics. I look forward to networking with other young advocates, learning from each other, and making a small contribution to the implementation of the WHO NTD Road Map 2021 - 2030.



## EDITORS CHOICE

#### KEY POINTS

- Only 14 publications from nine African countries identified - major evidence gaps
- Most national regulations guiding research are more than a decade old
- Consent and assent procedures for minors remain unclear and inconsistent
- Strong call for updated legislation, better governance and targeted **funding**




Figure 1: Study selection

Following **PRISMA** guidelines, the authors searched MEDLINE, Embase, PsycINFO, Global Health and relevant grey literature up to September 2023, without language or time limits. Out of initial 4,093 records. only publications met the inclusion criteria. These came from nine African countries (South Africa, Kenya, Nigeria, Uganda, Zambia, Ethiopia, Ghana, Rwanda and Tunisia), with South Africa contributing the majority. Figure 1 clearly visualises this stringent filtering process and underscores how little has been written about governance despite a growing of health research body mental involving young people.

#### **A Systematic Review of Research** and Governance in Child and Adolescent Mental Health in Africa Ojeahere et al. 2025

Children and adolescents with mental conditions are among the most vulnerable participants in health research, yet the rules that should protect them are often patchy or outdated. In this Editors' Choice open-access review, Ojeahere and systematically colleagues map how governance and legislation for child and adolescent mental health (CAMH) are framed across Africa. The authors focus on individuals aged 0-17 years and ask a simple but pressing question: what regulations and ethical guidelines actually govern CAMH research on the continent?

Across the included publications, most legal and policy frameworks guiding CAMH research were more than ten years old. The most recent regulation discussed was Uganda's 2017 child and adolescent mental health policy; several others dated back to the 2000s or even earlier. While global frameworks such as the Declaration of Helsinki, the Belmont Report, CIOMS guidelines and the UN Convention on the Rights of the Child provide general protection for human research participants, the review shows that these have not consistently translated into clear, child-specific regulations at national level. In many countries, individuals under 18 are legally minors and require parental consent, but national laws rarely spell out how to handle assent, confidentiality or the participation of children without available parents or guardians.



### EDITORS CHOICE

Thematic analysis of the 14 publications revealed five recurring themes:

- existing legislation is often perceived as unfavourable or overly restrictive for researchers and ethics committees:
- conducting research on the clinical frontline carries significant practical and ethical risks, especially in under-resourced settings;
- there is a strong call to action to address the dearth of African literature and the low priority given to CAMH research; (
- authors offer concrete recommendations, including intersectoral collaboration, new information-governance approaches and dedicated funding; and
- they outline new directions for research, such as epidemiological studies, school-based work, neurodivergence-informed research and projects focused on consent and capacity.




Figure 2: Frequency of themes coded stratified by African country. Of the 14 publications, five (36%) collected primary data, both qualitative (n = 4) [20, 26, 27, 31] and quantitative (n = 2) [31, 32], and the rest (n = 9, 64%) were text/opinion including narrative and scoping reviews. Themes were only extracted if they were supported by at least four articles to ensure that they were substantiated.

Figure 2 provides a striking visual summary of these findings. It shows both the concentration of evidence in South Africa and the broad spread of concerns about outdated legislation, unclear consent rules and the marginalisation of CAMH research in health agendas. Together, the review and its figures highlight a clear message: to protect children and adolescents with mental health conditions in Africa, research governance and legislation need to be updated, clarified and properly implemented - and CAMH research itself needs to move from the margins to the centre of national and regional priorities.

The Max Planck Institute for Infection Biology in Berlin is opening applications for its International Summer Internship 2026 (MPIIB-ISI). The programme offers three-month, fully funded research internships for international Bachelor's and Master's students with a strong academic record and a background in fields such as biology, medicine, biochemistry or epidemiology. Interns work on cutting-edge research projects under the supervision of experienced scientists, receive a monthly stipend of €1,400, travel support and housing near the institute, and benefit from a complementary training programme on scientific presentations, PhD applications and networking in Berlin's research landscape. The programme is specifically designed for students whose access to high-quality higher education is constrained; women and students from low- and middle-income countries are strongly encouraged to apply.

#### Implementation research for VL elimination in eastern Africa - TDR call



**ESCMID** Global

- Call for implementation research on visceral leishmaniasis (VL) in eastern Africa
- Up to 4 projects, max. USD 25,000 each, project duration up to 12 months
- Eligibility: institutions in LMICs, with VL/implementation research expertise
- Must be supported by the national VL control programme
- Deadline: 19 November 2025, 17:00 CET (online via eTDR)

TDR, the UNICEF/UNDP/World Bank/WHO Special Programme for Research and Training in Tropical Diseases, invites proposals to generate new implementation evidence for the Strategic framework for the elimination of visceral leishmaniasis as a public health problem in eastern Africa (2023-2030). Priority topics include national scoping reviews of VL research, analyses of implementation research capacity, studies on population vulnerabilities and health service access, socioeconomic impacts, screening and reporting gaps, vector mapping and outbreak investigations in VL-endemic and crossborder areas. Applicants must be researchers or health professionals based in public health institutions, universities, research institutes or NGOs in VL high-burden countries, with a demonstrable track record in implementation and infectious disease research and documented support from their national VL control programme. Applications (in English) are submitted via the eTDR online system using the official TDR grant application form.

#### **Workshop on Health Economics in LMICs 2026 (Rotterdam)**

- 4-5 June 2026, Erasmus University Rotterdam (Campus Woudestein)
- Focus: health economics research in low- and middle-income countries (LMICs)
- Keynote: Martina Björkman Nyqvist (Stockholm School of Economics)

The Rotterdam Global Health Initiative, Erasmus School of Economics and the Global Health Economics Working Group are organising the second Global Health Economics Workshop on 4-5 June 2026 in Rotterdam. The event will bring together development economists and health researchers working on LMIC-focused topics for in-depth discussions in a collaborative setting. A keynote lecture will be delivered by Professor Martina Björkman Nyqvist, and early-career researchers are particularly encouraged to submit full papers on health economics in LMICs by 1 December 2025. With support from RGHI, a limited number of travel grants are available; applicants should include a brief cover letter explaining their need for financial support.

#### ifa CrossCulture Programme (CCP) Fellowship 2026 Fully funded fellowships for civil society professionals



ifa CrossCulture Programme (CCP) Fellowship 2026 - Fully funded fellowships for civil society professionals

Key points

- **Application deadline: 10 December 2025**
- 2-3 month fellowship with host organisations in Germany or CCP partner countries
- For professionals and volunteers (23+ years) with ≥2 years' experience in civil society organisations
- Students are not eligible
- Fully funded: €650/month stipend, visa fees, round-trip airfare, accommodation, local transport ticket and health insurance

The ifa CrossCulture Programme (CCP) Fellowship 2026 supports 55-60 early- to mid-career professionals and volunteers from over 40 countries who are active in civil society. Fellows work for 2-3 months with a host organisation in Germany or another CCP country to deepen their expertise, build international networks and strengthen their transcultural skills. Priority thematic areas include policy and society, media and culture, human rights and peace, sustainable development and climate justice, with a 2026 focus on culture of remembrance and democratic resilience. Applicants must be at least 23 years old, have at least two years of professional or volunteer experience in a civil society organisation, and a solid command of English. The fellowship is fully funded and includes structured mentoring, a transcultural workshop and access to the CCP alumni network.

TWAS Research Professors in LDCs - Host a visiting professor

The TWAS Research Professors in LDCs programme enables universities and research institutes in Least Developed Countries to invite a TWAS Member or TWAS Young Affiliate/Alumnus as a visiting research professor for a short, intensive stay of two to four weeks within a one-year appointment. The visiting professor supports local research activities, offers advanced training and may deliver lectures and seminars, helping to strengthen scientific capacity and establish long-term collaborations. TWAS provides the visitor's travel costs and an honorarium, while the host institution covers local expenses. Requests must be submitted by eligible LDC institutions in the natural sciences by 9 December 2025.

ISGlobal is offering an online, part-time course on Travel Medicine and Health in Mobile Populations, providing a comprehensive clinical overview from pre-travel assessment to the diagnosis and management of imported and migration-related diseases in Europe. The course runs asynchronously between 12 January and 1 May 2026 and is divided into three stand-alone modules: Management of Travel-Related Diseases, Pre-travel Medicine and Consultation and Migrant Health. Using case-based interactive lessons, short videos and online clinical rounds, participants will learn to perform individual risk assessments, screen high-risk groups and manage common clinical presentations in returning travellers, migrants and refugees. Successful participants receive a certificate from ISGlobal.
