#### COMMUNICATION

An illustrated monthly e-bulletin newsletter was distributed to members during 2024 and paper copies were made available upon request to those members who have no access to the internet, who are invited to contribute towards the postage costs. The Friends website was kept up to date so that through the year it always carried the current e-bulletin newsletter.

#### **EVENTS in 2024**

The Friends programme of repair to the nave chairs led by Phil Morris continued throughout the year. Chairs are repaired at an average cost of £15/£20 per chair. The retail price of a new Coventry Cathedral Chair is £550, so each chair that is repaired saves the Cathedral approximately £530. Really good value.

In February a film show of archive footage related to the Cathedral was well supported. Amongst the films we were privileged to view a documentary about the Cathedral Architect, Basil Spence, that had been produced in conjunction with the Spence Archive in Edinburgh and only previously broadcast on Scottish TV.

A "Friendly Monday" gathering in April met Bishop Ruth Worsley, the Acting Bishop of Coventry. It was fascinating to gain personal insights into the life of the Bishop, who spoke movingly of her Coventry experience.

An organised tour of "Charterhouse" in May was an opportunity for members to learn more about one of Coventry's medieval jewels. This Carthusian monastery ended up in private hands at the dissolution of the monasteries, and it eventually became the family home of Col. Sir William Wyley by whose will it was left for use by the citizens of Coventry. There are strong links with the Cathedral for Col. Wyley not only served two terms as Mayor of Coventry, but he also served Coventry Cathedral as its Treasurer as well as Churchwarden.

For three weeks in June/July the Friends sponsored a well-supported exhibition in the Chapel of Industry of prints by Paul Catherall (see back page). The Lord Mayor attended the official opening. Paul spent his childhood in Coventry and was pleased to arrange a "Meet The Artist" event. In thanks he kindly donated a print of Coventry Cathedral.

#### **Financial Review**

#### The charity's policy on reserves.

Our expectation is that funds raised should be expended as soon as possible on the objects of the Friends – the promotion of the worship, work, and fabric of Coventry Cathedral. The policy requirements of the Cathedral mean that the funds raised will not necessarily be advanced on projects within each year. All funds will be used for our charitable objects over a reasonable time period.

The trustees have examined the Charity's requirements for reserves in the light of the main risks to the organisation. £5,000 is required for the working capital of the charity. Free reserves are invested for capital growth pending grant requests from the Cathedral Chapter. At the end of the year the free reserves totalled £171,244 which is £166,244 in excess of the working capital required.

During the year our priority has been to ensure that projects financed by the charity are carried out to a high standard and that they accord with the policy of the Cathedral Chapter. Each project is examined carefully to ensure that it falls within the definition of the charity's objects.

#### **Financial Review**

In the year 2024 income amounted to £14,480 (2023 £67,012) and expenditure totalled £12,583 (2023 £6,350) of which £7,972 (2023 £2868) was to gifts and donations resulting in a surplus of £5,703 (2023 £68,445). Our investments gained £3806 (2023 £7,783) in the year, resulting in an increase of funds of £5,703 (2023 £68,445). The total of funds carried forward was £182,450 of which £11,206 is for restricted purposes.

#### How expenditure has supported the key objectives of the charity.

In the previous financial year at an initial cost of £2568 the Friends acquired 3 original cartoons by John Hutton of a flying angel engraved on the west screen. The services of a specialist conservator have been arranged to remove the cartoons from their 1960s frames, to undertake any conservation work needed before reframing to the highest museum standards. That work has proceeded during 2024. The Friends Council has undertaken this project at an anticipated cost of approximately £20,000 so that this original work of art that relates to the foundation art of the building will be a true asset for the Cathedral.
