Short Biography

I was Chairman of the Landscape Institute's Education Committee and an elected member of the Institute's Council for over 15 years. I was also the founding President of the European Foundation for Landscape Architecture (EFLA), established to represent the professional associations of landscape architects within the European Union and concerned with the regulation and harmonisation of landscape architectural education and practice

within the EU. EFLA later became IFLA (International Federation of Landscape Architects) EUROPE in and expanded to better reflect the membership of theCouncil of Europe.

I am a former member of the Association of Planning Supervisors, the Society of Architect Artists and the Royal Society of Arts. I was made an Honorary Member of IFLA EUROPE at their GA meeting in Oslo in October 2014. I am currently engaged with IFLA Europe in the procedures concerning the migration of professional landscape architects within Europe. I am also currently working with the Council of Europe, European Landscape Convention as Rapporteur/Expert.

I have contributed articles to professional journals, illustrations for technical publications and given lectures and presentations at home and abroad for over thirty years.

In addition to practising as an architect and a landscape architect I am also a jeweller, with assay marks registered in Birmingham, a watercolour artist, a potter, a jazz musician, and an author. I have currently completed ten novels with a screenplay for the first novel.
