PCPA Regional Vice President & Senior Practice Pharmacist

She became a Professor of Clinical Pharmacy in 2022, a Fellow of both the Royal Pharmaceutical Society in 2023, and of the Pharmaceutical Society of Northern Ireland in 2024, in recognition of her work locally in NI and across the UK. Her research interests include experiential learning, prescribing skills and workforce development.

Taking up post in May 2020 following a successful HEE funded trial post for 1 year. Abbie runs face to face clinics with patients to review hypertension, lipid management, AF and inhaler technique reviews and is also trained in phlebotomy. Abbie has been recognised nationally by the SPS, MHRA and Regional Medicines safety officers and Chief NHSE Pharmacist David Webb for her work to improve safety around valproate in female patients and ensuring annual risk forms are completed for every patient in her PCN. As President of the PCPA, Graham is passionate about developing and promoting the role of pharmacy professionals in general practice and PCN at a local and national level.

Graham has practiced in Primary Care for more than two decades, developing an interest in deploying pharmacy teams with full skill mix from trainees to advanced practitioners across general practice, PCN, care homes and community. HELEN WILLIAMS

National Clinical Director for CVD Prevention, NHSE -Consultant Pharmacist and PCPA Cardiovascular Specialist Pharmacy Lead

As Consultant Pharmacist for CVD Disease, Helen is involved in a wide range of activities across South London to improve the care of patients with or at risk of cardiovascular disease (CVD). Helen chairs the local cardiovascular medicines working group which develops and supports the implementation of consensus evidence-based guidance for use across South London's 12 clinical commissioning groups and 7 acute trusts, covering a population of 3.6million.

There is a strong focus on medicines optimisation for long term conditions such as heart failure, hypertension and atrial fibrillation with the aim of reducing the burden of acute hospital admissions and she has been involved in supporting primary care practitioners through guideline implementation, clinical audit and provision of pharmacist-led virtual clinics. A key focus over recent years has been to increase the proportion of patients with AF who are anticoagulated to reduce the incidence of AF-related stroke and Helen is now focusing on the rollout of mobile ECG devices to improve the detection of AF.

In addition, Helen is an editorial board member for the British Journal of Cardiology and the Journal of Medicines Optimisation and works with NICE on the development of a number of cardiovascular guidelines.
