Our online meetings are now once a month.



Co-producing Accessible Legal Information



We are working on a new project with the research team led by at the University of Birmingham.

The project brings legal professionals together with disabled people to co-produce accessible legal information and explore the relationship between legal advice and legal information.

In July we presented at the Third UK and Ireland Mental Diversity Law Conference in Nottingham.

We will work together to:

• Choose the most important legal topics for accessible information.

- Make accessible legal information for disabled people
- Make a guide for other people who want to do co-production.

We will also produce some accessible legal information templates that participants will be able to share with their firms and colleagues.

Free Our People Now Campaign

The project will be able to offer training, information and support so we have more Disabled people helping other Disabled people to leave hospital.

Public consultations on rail ticket office closures across the country have been happening. Some of these ended Wednesday 26th July but we want to keep up the pressure.

Policy news

Do you know what a Dynamic Support Register is?



A Dynamic Support Register is a list of people with a learning difficulty/disability and autistic people who need extra support for their mental health.

The NHS say that 'people who are on the Dynamic Support Register are at risk of going into hospital if they do not get the right care and treatment in the community.'

Because there have been many cases of abuse and poor care in some mental health hospitals the NHS has a new policy for people to get the right support, at the right time, and in the right place.

The new policy is about 2 important things.

- 1. Staff in each local area must know who is in danger of going into hospital because of a mental health crisis. The list of people who might need this extra support is called the **dynamic support register** (DSR).
- 2. There must be reviews to check people are getting the right care and treatment for their mental health. For adults this is called a care and treatment review or CTR. These reviews are not new. But the new policy says more about how they must work. Reviews must be about more than just people's care and treatment. They must be about people having a better life as well
