How to make your Will

By making your Will through our partner, The National Free Wills Network, you'll be connected with a qualified solicitor that's local to you. They'll help you write or amend a simple Will for free.

If you're considering including a gift to Providence Row when you make your Will, it can be helpful to think about the gift you might want to leave. There are three main types:

- Residuary A percentage of your estate after your other beneficiaries have been provided for.
- Pecuniary A fixed sum of money.
- Specific A particular item, such as property, antiques, jewellery or shares.

Your solicitor will take care of the rest. They'll help you decide what's right for you and make you aware of everything else you need to consider when making or amending your Will.
