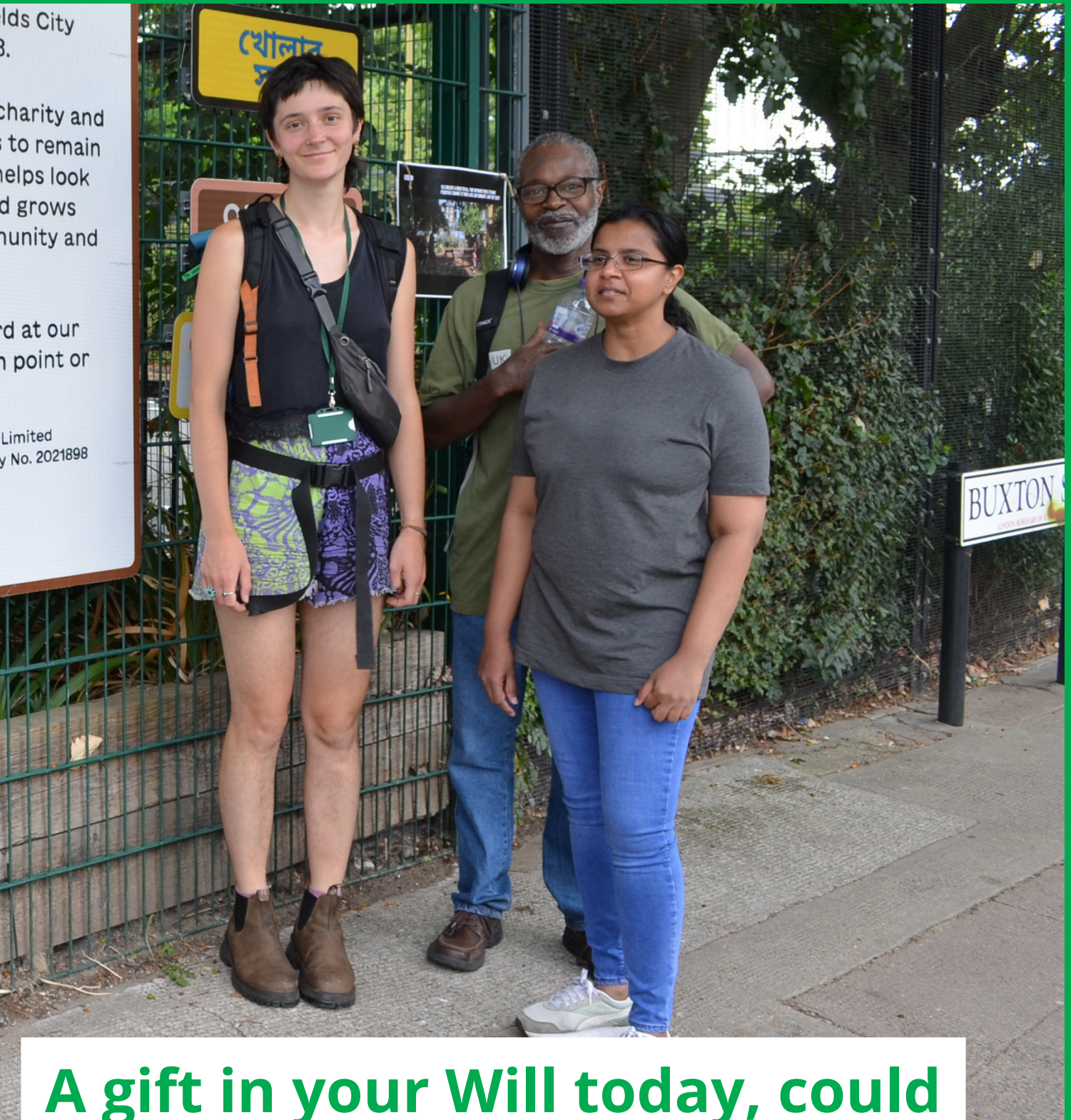

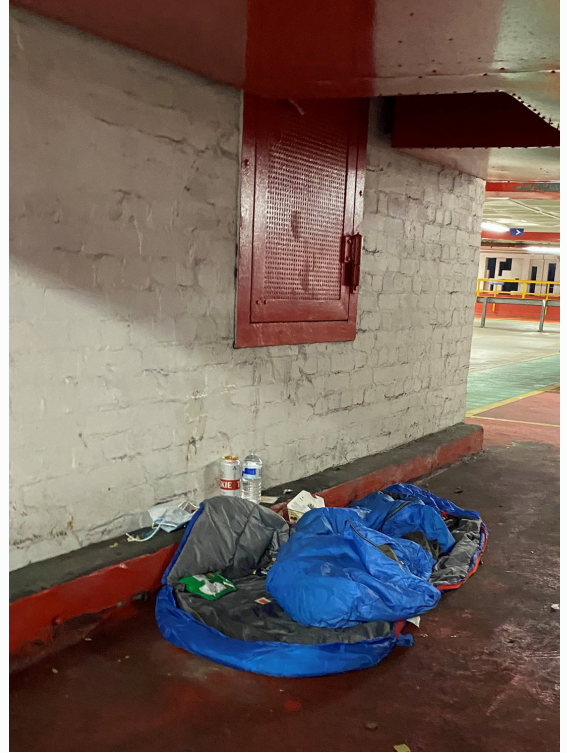


**A gift in your Will today, could

Daniel was sleeping rough in Tower Hamlets following a breakdown in his marriage. His mental health suffered and he lost his job and his home. With nowhere else to go, he endured many nights of sleeping rough.

"I was already suffering with my mental health but when I ended up on the streets I started drinking to make coping easier, but actually I was just making myself worse. When you have nothing, it's so easy to give up on yourself. I just felt worthless. I had never even heard of Providence Row, but when I found temporary accommodation, I was put in touch with them and it was the best thing that could have happened to me."

"I can't thank Providence Row enough for what they have helped me achieve. I have recently started a job in a supermarket, restocking the fruit and vegetables. Now that I have an income, I can start looking for a permanent place to live, finally my future is looking bright."
