

# **Cookies Policy**

This Cookies Policy explains how Spinnaker Trust Ltd uses cookies and your options relating to their use.

#### 1. What are Cookies?

Cookies are small text files stored on your device when you visit a website. They help the website remember your preferences, improve performance, and deliver a better browsing experience.

Cookies can be:

- First-party cookies set by our website
- Third-party cookies set by external services we use, such as analytics tools

# 2. Types of Cookies We Use

We use the following types of cookies:

## **Strictly Necessary Cookies**

These cookies are essential for the site to function and cannot be switched off. They are usually only set in response to actions such as logging in or filling in forms.

#### **Performance Cookies**

These cookies collect anonymous information about how visitors use our website, such as pages visited and links clicked. We use this data to improve how our website works.

#### **Functionality Cookies**

These cookies allow the website to remember choices you make (e.g., your name or region) and provide enhanced, more personalised features.

## **Targeting or Advertising Cookies**

We do not use cookies for advertising purposes. However, third-party platforms (e.g. embedded content from YouTube or social media buttons) may set cookies.

Cookie	Name	Purpose	Category
Session cookie	SESS<>	Used to track a person's status, such as whether they are logged in.	Strictly Necessary
JavaScript	has_js	Checks if a browser can run JavaScript, which is needed for the site to work properly.	Strictly Necessary
Google Analytics	_ga,_gid, etc.	Collects anonymous information about how visitors use the site.	Analytics / Optional
