Mike Wistow

Ut joints

Mike has a long history of involvement with public and charitable sector organisations. He has previously been a Trustee in a Community Arts organisation and a College of Further Education. He is the founding Director of Aegir Consulting Limited which has worked with several Third Sector bodies on developing and implementing longer-term strategies.

Mike was previously Secretary, and then Chair of NPRIE, the national Probation research body, working with the Home Office, universities and Criminal Justice bodies to understand what constitutes effective intervention. This then informed national policy to move in the direction of evidence-based practice. Mike is currently a Trustee for Lincolnshire Action Trust as well as UKSCS.

During his period as a Trustee for UKSCS, Mike has focused on wider engagement: interviewing Rose Marley after her first hundred days in post, an interview which became the basis of an article for the Journal; developing an understanding of the wider community that UKSCS works with so that interactions can be more useful; setting up and hosting Cooperative Conversations - a three/four times a year on-line Conversation of interest to members and friends of UKSCS.
